

Modern Construction - Technology & Innovation (Part 2)

Modern Chemistry for Bathrooms & Wet areas

Using tile adhesives & tile grouts, is still not a convention in India, although the tile adhesives manufacturing companies have made great progress

High performance cementitious coatings followed by applying tile adhesives & chemical resistant tile grouts in tile gaps, though prevalent in large projects, is yet to put into practice for homes and residential buildings.

With changes in life-style, the tile industry is going through a revolution, with tiles manufactured in different types, bigger sizes and shapes. This has necessitated different types of tile adhesives and tile grout.

The adoption of epoxy tile grouts is happening fast in India

There is a significant demand for tile grouts to coloured to match tiles' colours and resistant to washing & cleaning chemicals in bathrooms and in the utility spaces in apartments. Epoxy tile grouts provide exceptional resistance to these activities, while not compromising on aesthetics

Today, the best of 'Tile Adhesives, Cleaners & Stone Care Technologies' is at our doorsteps. Just asking for professional help, will make wet areas absolutely water-tight, coupled with pre-packed cementitious grouts applied around pipe inserts and Nahani traps

For floors laid with marble and other stone tiles, protecting them with sealers surface and cleaning is another technology, that is extremely important to keep stone tiles fresh looking for a long time, lending easily cleanability

As against traditional floor laying with sand and cement slurry, today we have pre-packed floor self-levelling mortars that can provide that can be laid to perfect levels that serve as a proper levelled bed, for tiling work on floors. These self-levelling or trowelled mortars can be laid from 1 mm onwards till 40 mm, over which tiles can be laid with adhesives, with the optimal consumption, with higher turn-out per day.

Modern Chemistry in Cementitious Floors

'Continuous cementitious floors' technology has come of age for applications in office interiors, large commercial spaces, malls, multiplexes & institutional buildings, that deliver extremely tough abrasion resistant finishes along with polished surfaces, without blemish & ensuring a 95% + levels of flatness.

In public buildings, conventional centres and airport terminals, the chemistry of terrazzo floors, in epoxy or cementitious types can be laid in designs of choice. If laid by skilled applicators, such floors make a statement. Terrazzos can be replaced with expensive marble or granite floors, while delivering a jointless finish that enhances aesthetics, and deliver hardwearing finishes, hygiene and cleanability.

On the other hand, creative & coloured finishes can be applied onto cementitious toppings, mentioned above.

Modern Solutions for Basements

Basements, needless to say are the 'Achilles Heel' of Buildings, where invariably the maximum attention is given, not only by consultants & architects but also the EPC contractors and the applicators fraternity.

These important areas are no longer just hidden foundations, but have transformed into vibrant, functional spaces that add value to any building. In urban construction they are getting deeper and encounter a variety of hostile elements in the sub-ground, and become prone to deterioration, mostly from the urban elements of soil contamination, effluents release and the zero property line issues where an existing urban property is just next to the construction of a new structure.

All these pose changes and hence every year, we come across new technologies emerge for making basements more secure in terms of keeping the interiors dry for functional aspects such as office spaces, dispensaries, data centres, server rooms, car parking, restaurants and many more.

Today there is a need to improve the concrete properties, making it denser and more impermeable. But the important thing to remember that this should be pronged approach, that is improving the quality & density of concrete, and an effective waterproofing barrier over concrete on the positive side, to provide protection to concrete in footings, piles and pile caps, concrete rafts and the retaining walls.

The newer chemistries in polyureas and the new pre-formed membrane technology need to be carefully considered.

Apart from HDPE, there are newer materials such as 'Self Healing' membranes, which when installed, solve problems of effectively blocking of water entry where dowel bars are provided in D Wall to Retaining Wall points, etc.

This self-healing waterproofing membrane isn't just a product. It is a solution to the age-old problem of water ingress, primarily due to membrane tearing or puncturing during the on-going construction activities, which are next to impossible to repair.

In such areas, HDPE membrane installation is not possible, thus making the "Self Healing Membrane" option will become imperative in the near future.

In such areas HDPE cannot be installed.

In polyurea technology, water-based polyureas today, make it possible for application, where moisture content in concrete is still high.

Moisture triggered waterproof coatings are also a latest arrival, where they can be applied on retaining walls, immediately on striking off the formwork after due surface preparation. Expansion joint sealants that are also moisture triggered are now available to compliment these coatings. In monsoons, the moisture triggered technologies can be applied during dry the spells. This technology is 'value for money' where it helps engineers to speed up their construction activity.

New Materials in Roofing & Terrace Waterproofing Applications

Like above new chemistries in polyurea technology, "Water Based Polyurea" has arrived and is here to stay. Besides being 'Green', the ground breaking advantages, this chemistry offers are high open time in application, applied on moist concrete substrates, and can be roller and spray -applied comfortably. This new coating membrane serves as a tough undercoat and can facilitate delays in the overlays on protection screeds in sites.

Roofing & Re-Roofing Technology will see even more rapid changes in the future.

The discussion emphasized the need for better alignment with regulatory standards and enhanced safety requirements for high-rise constructions. The attendees from CREDAI-MCHI included Shri Keval Valambhia, COO; Ms. Maidini Date from Romell Group; Shri Sanjay Phope, Senior Executive – Liaison; and Shri Sanjay Yedge, Executive – Liaison.

The Griharmony Redevelopment Stakeholders Federation (GRSF) held its inaugural board meeting on Tuesday, August 27, 2024, where a significant decision was made to appoint Shri Dominic Romell as Head of the Technical Department of GRSF.

Shri Romell's extensive expertise and leadership are expected to play a crucial role in advancing the Federation's mission of enhancing the redevelopment process for housing societies across Maharashtra. On Friday, August 30, 2024, a suggestion meeting was held with the advisor appointed by the Housing Department to discuss policy changes aimed at expediting the redevelopment and self-redevelopment of properties in Maharashtra. The State Government has appointed Mr. Rajendra Mirgane as the advisor to MHADA and the State Government to promote redevelopment initiatives in the region.

During the meeting, CREDAI-MCHI presented several key proposals, including the introduction of a 10:10:80 schedule for the payment of MHADA premiums, the provision of entire fungible compensatory FSI on rehab components not exceeding 35 sq. meters without charging a premium, allowing the deduction of the actual rehab area and charging a premium only on the sale area, and granting NOCs to developers upon request from the developers by the resident executive engineer. The meeting was attended by Shri Ricardo Romell, Committee Member; Shri Keval Valambhia, COO; and Shri Harish Gupta, Assistant General Manager.

Meeting with Smt. Jayashreerani B. Surve, Dy. Director

On August 8, 2024, a meeting was held with Smt. Jayashreerani B. Surve, Deputy Director, to discuss the impact of high Ready Reckoner (RR) rates. Representatives from CREDAI-MCHI and Naredco attended the meeting and submitted a representation highlighting concerns about the current RR rates, specifically pointing out that the cost of construction and GST are not being factored in.

Both points were duly considered, and confirmation from the IGR office indicated that while the RR rates for built units, both commercial and residential, might be reconsidered, the land RR rates will remain unchanged for the next year.



Meeting with DC Gurugram

On August 1, 2024, the Deputy Commissioner (DC) of Gurugram met with key representatives of the CREDAI NCR (Haryana Chapter) to address maintenance issues in Group Housing Societies. Discussions focused on the unfair liability placed on Developers/Builders by a recent Notice and proposed clear mechanisms to assign maintenance responsibilities appropriately. 'Property mkt sentiment to improve as govt gives options on LTCG tax'

Property owners will have a sigh of relief and market sentiments will improve with the Centre deciding to give taxpayers the option to choose between the new 12.5 per cent long-term capital gain (LTCG) tax rate and the old 20 per cent rate with indexation benefit for assets purchased before July 23, according to industry bodies.

Realtors' apex body CREDAI President Boman Irani said the recent amendment in the long-term capital gains tax and indexation benefits is a welcome move by the central government.

Finance Minister Nirmala Sitharaman, who in her budget for 2024-25 proposed to cut LTCG tax to 12.5 per cent from 20 per cent but without the indexation benefit, moved an amendment to the bill to give the option. Indexation benefits allow taxpayers to arrive at property cost after adjusting for inflation.



Stability in mortgage rate to maintain strong housing demand: Realtors'

The housing market will continue to see strong demand in the coming months as mortgage rates are likely to remain stable following the RBI move to keep the repo rate unchanged, according to real estate developers. They are hopeful for a rate-cut in the next monetary policy committee meeting.

"Commenting on the RBI policy, realtors body Credai President Boman Irani said, "RBI's decision to keep the repo rates unchanged at 6.5

per cent would maintain the borrowing costs for homebuyers and their ongoing home loan EMIs.

However, we do expect and hope for a rate cut in the upcoming MPC meets, given the relatively favourable macro-economic dynamics."

STABLE ENVIRONMENT
NAREDCO President G Hari Babu the central bank's decision creates a stable environment for the real estate sector.

"With steady borrowing costs, home loans become more affordable, which is likely to boost demand in the

housing market, especially during the upcoming festive season.

This stability allows developers to plan projects confidently, knowing that financing conditions will remain favourable. "In addition, Leading housing brokerage firm Anarock Chairman Anuj Puri said this sets a positive tone for the housing industry.

Housing.com Group Chief Executive Officer Shraw Agarwala stated that stable home loan interest rates continue to support robust demand in India's housing sector.

Residential realty in B'luru sees 28% price rise in Q2 of 2024

Average price now at Rs 11,161 per square foot

Delhi NCR and Bengaluru saw the highest quarterly housing price rise in India at 36% and 28% respectively between April and June this year (Q2 2024), while the average across the top eight Indian cities was a 3% quarter on quarter (QoQ) growth in the same time period.

Bringing this to light, a report released on Monday by the Confederation of Real Estate Developers' Association of India (CREDAI), professional services and investment management company Colliers, and non-brokerage real estate research company Liasas Foras, added that Bengaluru's residential price for Q2 2024 has reached an average of Rs 11,161 per square foot (sq ft), up from an average price of Rs 8,688 per sq ft in Q2 2023. On a quarterly basis, Bengaluru's price rose from Rs 10,377 per sq ft in Q1 2024.

Within Bengaluru, the inner east micro market saw the highest quarterly rise at 25% followed by the periphery and outer east micro market at 20%. Led by heightened demand in the luxury segment, inner east and periphery and

outer west micro markets also witnessed a significant surge in average housing prices for ready units.

The report, however, found that the quarterly price movements at India level have been almost similar at about 3% for the last four quarters. This stability in price growth is reflective of steady underlying demand over the last few quarters.

Average housing prices surged 12% year-on-year (YoY). Seven out of eight cities under review witnessed annual price appreciation, with Delhi NCR witnessing the highest price rise at 30% YoY, closely followed by Bengaluru at 28% YoY.

"Sales across India's cities have maintained growth despite the price rise. The current quarter showed a remarkable 33% increase in new launches in the affordable segment," said Pankaj Kapoor, Managing Director, Liasas Foras.

"Within the residential market, demand growth has been the strongest in luxury and ultra-luxury segments including second and vacation

homes which is evident with price growth in select micro-markets of Delhi NCR and Bengaluru. Average housing prices for spacious dwelling units, particularly 3-4 BHK configurations in these cities have increased up to 30% on an annual basis," said Vimal Nadar, Senior Director and Head of Research, Colliers India.

While unsold inventory remained stable on an annual basis at a pan India level, it dropped by up to 5% on a quarterly basis except in Mumbai Metropolitan Region (MMR). As of Q2 2024, there was an availability of over 10 lakh housing units across the primary market of eight major cities, with MMR alone having about 40% share in unsold inventory levels.

Despite yearly increase in the number of unsold units in Hyderabad and Bengaluru, both cities saw a modest dip on a sequential basis. As the festive season approaches, developers are likely to closely monitor new launches and overall housing stock in prominent residential catchment areas.

AVG HOUSING PRICES IN TOP 8 CITIES SURGE 12% IN APR-JUN; DELHI-NCR SEES HIGHEST RISE



India's housing market has continued to exhibit steady growth in Q2 of 2024, with average prices across the top eight cities increasing by 3 per cent quarter-over-quarter, according to a report by Confederation of Real Estate Developers and Associations of India and property consulting firms Liasas Foras and Colliers. On an annual basis, average housing prices in the eight major cities rose by 12 per cent, with Delhi NCR leading the way at 30 per cent.

NCR tops with 30% housing price surge

Average housing prices grew by 12% annually during the April-June quarter across eight major cities with Delhi-NCR witnessing a maximum 30% appreciation, according to a report by CREDAI, Colliers and Liasas Foras.

Realtors body CREDAI, property consultant Colliers and data analytic firm Liasas Foras have released *Housing Price Tracker Report Q2 2024*.

On an annual basis, the average housing prices at the end of June quarter have shown a 12% growth across the eight major cities.

Interestingly, seven out of eight cities under review witnessed annual price appreciation, with Delhi-NCR witnessing the highest price rise at 30% year-on-year.

According to data, housing prices in Ahmedabad rose 13% to ₹7,335 per sq ft in April-June 2024 from ₹6,507 per sq ft in the year-ago period.

In August, we garnered a total of 39 stories, including 12 in print and 27 online, resulting in a PR value exceeding ₹ 2.09 crore. We anchored our industry thought leadership by contributing to stories on the Repo Rate and the recent revision in Long-Term Capital Investment, reinforcing our position as the leading voice in the real estate sector.
